## **ECCRT PRIVILEGE CARD TERMS AND CONDITIONS**

### **INTRODUCTION**

The ECCRT Privilege Card System is operated by ECCRT, a company incorporated in Belgium, with registered office at ECCRT Marcel Broodthaers plein 8 - box 5, 1060 Brussels.

Access to the offers and benefits of the ECCRT Privilege Card is available and strictly limited to those members who have accepted the present terms and conditions of the use of the ECCRT Privilege Card.

### **ELIGIBILITY FOR MEMBERSHIP**

ECCRT Privilege Card membership is subject to receipt by ECCRT of a membership application (via an email to [info@eccrt.com](mailto:info@eccrt.com)) and acceptance of the membership by ECCRT.

Privilege membership is available for companies attending ECCRT courses. Companies are identified by their VAT number and/or office location (i.e. a combined ECCRT Privilege Card cannot be requested for companies with the same name but different VAT number of office location)

ECCRT Privilege Card members will receive an email, indicating their company name and ECCRT Privilege Card membership number, after completion of the 1st course.

### **ECCRT POINTS**

Once membership is confirmed, members may collect ECCRT points whenever sending employees to a course on any ECCRT's course location. ECCRT points can also be collected for tailored courses (1 tailored course counts for 1 ECCRT Privilege Card entry).

Per ECCRT Privilege Card entry, the amount of ECCRT points is calculated as 10% of the total course cost for that training date (excluding the course fees mentioned hereunder).

No ECCRT points will be credited in respect of:

- Registrations via references through special promotion codes,
- Fees for travel or accommodation, travel time of trainers, administration costs, course material and training location (in case of ECCRT tailored courses).

ECCRT points in respect of the same course (defined by course name & course date) or project can, evidently, only be accrued on 1 ECCRT Privilege Card and may only count as 1 entry. ECCRT points can be claimed up to 6 months after the course date.

Entries on the card are always done in chronological order of course dates.

### **REDEMPTION OF ECCRT POINTS**

Members may redeem their ECCRT points as soon as the ECCRT Privilege Card is full (i.e. 4 entries have been made and signed off).

The ECCRT points can only be used as a discount on the invoice of the 5<sup>th</sup> entry. The 5<sup>th</sup> entry does NOT count for ECCRT points and can thus not be added as a new entry on the new ECCRT Privilege Card.

## **ECCRT CARD GENERAL TERMS AND CONDITIONS**

1. By using the ECCRT Privilege Card, members will be deemed to have accepted the current ECCRT Privilege Card Terms and Conditions which will be available to view on the ECCRT website. ECCRT may change these terms and conditions at any time by posting revised terms and conditions on the ECCRT website. Any change or revision shall take effect immediately. At any time during their membership, members may request a copy of the current terms and conditions of the ECCRT Privilege Card, by e-mail ([info@eccrt.com](mailto:info@eccrt.com)) or telephone (+32 2 892 40 00).
2. The ECCRT Privilege Card is not transferable to any other party. All ECCRT Privilege Cards remain the property of ECCRT and may not be used after the expiry date and/or termination of the ECCRT Privilege Card membership.
3. ECCRT cannot guarantee the accuracy of the special offers and discounts and it is the responsibility of the cardholder to verify all information prior to purchasing a course or services.
4. The card will be stored in ECCRT offices. The available special offer or discount will be obtained as the ECCRT Privilege Card is signed off by a ECCRT team member, on the day of the training. The ECCRT Privilege Card will only be signed off if the course fee has been paid. The new overview will be mailed so the ECCRT Privilege Card member can keep track of any changes.
5. All special offers and discounts are subject to availability and the ECCRT team reserves the right to cancel offers at any time without notification.
6. ECCRT points will only be granted to direct subscribers to ECCRT. Any reference by other companies or with special promotions will not result in points on the ECCRT Privilege Card.
7. ECCRT cannot assume liability for correspondence, mail or e-mail, which is lost, delayed, or misdirected either to ECCRT or to participating businesses or organisations.
8. The initial term of membership commences on the first training date mentioned on the ECCRT Privilege Card and is valid (a) for 2 years after the date mentioned and (b) until the date on which the member ceases to be a member of the ECCRT Privilege Card. However, members have the right to cancel their membership at any time.
9. ECCRT may terminate any membership of the scheme, without notice, for any reason in ECCRT sole discretion, including without limitation ECCRT's belief that continued use of such membership would violate any provisions or these terms and conditions, applicable laws, or otherwise be harmful to ECCRT interests.
10. Use of the ECCRT Privilege Card is at members' sole risk and ECCRT shall not be liable for any direct, indirect or consequential losses resulting from the use of the ECCRT Privilege Card. Membership benefits are provided on an "as is" and "as available" basis. ECCRT expressly disclaims all express or implied warranties of any kind, whether relating to the courses, the membership or the quality of any service purchased or obtained by a member from the use of the ECCRT Privilege Card.
11. This agreement shall be governed by Belgian laws and members agree to submit to the exclusive jurisdiction of the courts of Belgium.
